Greg Galvin made a motion, seconded by Brian Thompson to approve the minutes from the December 22, 2015 regular Board meeting as presented.

Brian Thompson made a motion to approve and sign the Bill Warrant for January 2016, seconded by Greg Galvin.

John Reilly has also asked the Board begin the process of looking into current retirees who may be eleigable for a spouses health insurance benefit, but take the town health insurance as a result of the policy that you cannot carry health insurance if you go off of it for any period of time. He anticipates some cost savings in this area. Lauren Durham and Mike Buckley will beging gathering information on who this policy change may effect.
