1.0 Call to Order

4.0 Student Representative

Emily and Erin O'Donnell, both seniors, reported the following:

- Update on theatre this year's plays included a *Midsummer Night's Dream* and *The Drowsy Chaperone*. Students attended a theater festival and competed against 6 schools in Duxbury. Hull students directed the play *All I Really Need to Know I Learned by Being in a Bad Play*. Hull won 3 awards.
- Spring Sports baseball's current record 2-1. Softball, lacrosse (boys and girls) and track have begun.
- Most seniors have received most of their college acceptances, notable schools include: MIT, MCPHS, Boston College, Northeastern and various Massachusetts state schools.
- Currently five (5) members of the graduating class have committed to serving in the U. S. Armed Forces.

6.1 South Shore Vocational Tech Study Committee

Mr. Hipp introduced Ms. Jennifer Constable, Chair of the South Shore Vocational Tech

Study Committee, who gave an overview of the SSVT Committee's charge from Town Meeting to seek and authorize to enter into an agreement to become a member of SSVT. She said that before the committee can know the feasibility they must first gauge interest. Ms. Constable said that the committee envisioned having the Votech come in for an informational session so they can get a real number of students who are interested in attending. When asked what the current process is when considering high school plans, Ms. Rebecca MacDonald, Memorial School Adjustment Counselor, told the committee that she visits with each eighth grader at lunch and asks if the students have any questions about paths to take. If students express interest she makes follow up appointments with them and their parents. School Committee members voiced their concern of having the Votech come to the schools when no other public or private school has ever done that and it should be the parents and students responsibility to seek out a different school, with the informational help from Ms. MacDonald. Committee members also discussed the acceptance policies that have recently changed, therefore allowing Hull students a better opportunity to get accepted to the Votech without being a member school.

Ms. Judith Kuehn, Assistant Superintendent, gave a brief overview of the Youth Opioid Prevention Grant. The grant is a competitive grant specifically designed to help reduce the risk for addiction among young people through prevention programming. Hull Public Schools was chosen as a recipient and will receive \$19,000.
