SCHOOL COMMITTEE MEETING MONDAY, MARCH 3, 2003

SCHOOL COMMITTEE MEMBERS PRESENT

Christopher Shipps chaired the meeting.

Budget meeting began at 6:12 p.m.

Superintendent read the name and the amount of school grants totaling \$1,307,356 for FY02 and \$1,264,854 for FY03 that have been brought into HPS by Dr. Gerald Fournier. Dr. Reynolds noted that the school budget dated 3/3/03 has been changed to reestablish high school track.

Rhoda Kanet requested a description of each grant and what each grant is being used for. Superintendent stated she would bring that information to a future School Committee meeting.

Stephen Avakian requested an analysis on Hull regarding the new DOE special education formula for students. Superintendent responded she would request Linda Gill, Special Education Director, to respond to this issue.

Christopher Shipps requested placing Representative Garrett Bradley on the March 24th School Committee agenda to discuss the state fiscal situation.

Rhoda Kanet voiced her concern about the increase in the Special Education Director's salary. Superintendent responded that the HPS Special Education Director is one of the lowest paid in the state. Christopher Shipps requested that the Superintendent send School Committee documents regarding Special Education Directors' salaries.

Jack Wholey, High School Council Member, discussed special education issues.

School Committee requested the following information:

- What are the prototypes of special education students that are being sent out of district?
- Is Hull per pupil cost for special education students more than surrounding towns?
- Are the students that go to alternative schools being counted in the Hull pass / fail MCAS rate?

Stephen Avakian asked if the school budget included any provisions for any new administration positions. Superintendent responded that the budget did not.

Stephen Avakian made a **motion** to adopt the central office budget in the amount of 3,343,052. John Lidington seconded the motion (see vote below).

School Committee requested the Superintendent to schedule a meeting with the Town Manager, Carl Katzeff, and a member of the Finance Committee to get a consensus on the school budget regarding Memorandum of Understanding dated May 14, 2002. School Committee also requested a copy of the Memorandum of Understanding sent to them.

School Committee voted unanimously on Stephen Avakian's motion.

Stephen Avakian made a **motion** to adopt the school budget as presented on March 3, 2003, in the amount of \$11,903,505. John Lidington seconded the motion. All members voted unanimously to accept the motion.

Rhoda Kanet made a **motion** to adjourn the budget meeting at 7:15 p.m. John Lidington seconded the motion. All members voted unanimously to approve the motion.

Regular School Committee meeting began at 7:40 p.m.

Rhoda Kanet left the School Committee meeting due to a prior commitment.

Chair stated that this meeting would be a continuation of the March 3rd School Committee meeting.
