SCHOOL COMMITTEE MEETING MONDAY, SEPTEMBER 13, 2004

1.0 Call to Order

Chair called the meeting to order at 7:10 p.m. with the Salute to the Flag.

2.0 Approval of Agenda

Chair requested adding 5.7 – Transfer of Funds to the agenda. Rhoda Kanet made a **motion** to approve tonight's agenda with requested change. Catherine Bowes seconded the motion. All members voted to approve the motion.

5.0 Business Items – Superintendent

5.1 School Opening

Superintendent stated that Hull Public Schools had a smooth school opening and is off to a great start.

5.2 Enrollment Figures

Superintendent reported on the student enrollment for the opening of school. There is a student increase at Hull High School. Class sizes are good.

5.3 Director of Student Services

Superintendent updated School Committee on the Director of Student Services position as follows:

5.4 Nature's Classroom

Kathleen Sullivan, Memorial Middle School Teacher, spoke about the team building sixth grade students receive while attending Nature's Classroom. Nick Boretti, and Olivia Fitzpatrick, Memorial School students, discussed their experience while attending Nature's Classroom last year. Ms. Sullivan invited School Committee members to attend Nature's Classroom.

Catherine Bowes made a **motion** to approve the Nature's Classroom trip on October 5 - 8, 2004 in Groton, MA. Rhoda Kanet seconded the motion. All members vote to approve the motion.

Superintendent commended Memorial School staff for having the Nature's Classroom trip at the beginning of the school year.

5.5. Student Surveys

Russell Goyette, Hull High School Principal, stated that only five percent of parents responded to the high school survey. Dr. Goyette gave an overview of the parent responses in all four categories.

Bruce Berman, Memorial Middle School Principal, stated that nine percent of parents responded to the Memorial School survey. Mr. Berman discussed the responses that were received in the survey. He stated that he was surprised with so few parent responses and asked the public to come and visit the Memorial School.

School Committee suggested enclosing a stamped self-address envelope with future surveys.

5.6 Vocational Educational Transportation

Superintendent stated that because of the recent revision in the law, Hull is entitled to receive a fifty-percent reimbursement for vocational transportation costs. Dr. Delaney discussed a letter from Blue Hills Vocational School requesting transportation for the eight students attending that school. She noted that vocational transportation had been cut from Hull's FY05 budget.

School Committee requested the following information:

Rhoda Kanet suggested increasing the electrical line items for all schools in the FY06 budget.

Chair suggested that the Jacobs School send out a mid-year letter regarding all that is happening at the kindergarten full day classes. Catherine Bowes suggested utilizing the Hull Times and the Patriot Ledger.
