7.0 Business Items - Superintendent

7.1 2007 Budget

Dr. Delaney stated she wanted to clear up any misunderstandings about cuts that were made from the FY07 budget. All three schools received cuts in their budget in order to arrive at the acceptable bottom line in the FY07 budget.

7.4 Tour of High School

School Committee members, Superintendent and members of the audience received a tour of the television production studio conducted by Peter Seitz, Program Director for Channel 22. The next area on the tour was the Industrial Technology Education area where Bryan Conklin, ITE teacher, explained what students are taught in the metal and wood shops and samples of student projects were displayed. The tour continued into the WAVE Publishing room where students learn journalism and publishing. The last part of the tour included the computer and business labs that are located on both the first and second floors of the high school. Some of the items taught in these courses are MS Word, MS Power Point and MS Access applications. During the entire tour James Griffin, Facilities Manager, pointed out the many areas that have not been completed and the workmanship that is not acceptable during construction at the high school.

7.3 ITE Field Trip

ITE teacher Bryan Conklin requested approval to bring twelve students to attend the Granite State 2006 Wood Turning Symposium on May 12, 2006 at Pinkerton Academy in Derry, New Hampshire. This field trip would introduce students to the art of woodturning and the skills used in the trade.

Labor Day is early in September this year and the school year would end the middle of June. Catherine Bowes suggested starting the year earlier, getting more accomplished for students.

Information on summer school was presented to School Committee. Dr. Delaney explained that the summer school program is self-supporting, scholarships are

provided to students and students on IEP's attend at no cost with a referral from teachers.

7.7 Home Schooling Information.

Dr. Delaney stated that at present twelve students are being home schooled. Parents submit a letter to the Superintendent indicating they will be home schooling their child. A meeting is scheduled for the parent(s) to meet with the Superintendent and work samples are required to be submitted.

7.8 Update on Administrative Searches

The last interview for the Director of Instructional Services is scheduled for March 29th. After the final interview, one to two candidates will be asked to return for a final interview.

Seven candidates will be interviewed for the Director of Business and Finance position. Interviews will be held during the first week in April.

Dr. Delaney will meet with teachers on April 5th and parents on April 11th to discuss a profile for the new Jacobs School Principal. A Screening Committee will be set-up and the same process will be followed as the two Director positions.
