# 7.3 New England Theatre Conference – Mr. Joseph Doniger

Mr. Joseph Doniger, Theatre Director, requested permission to bring theatre arts students to attend the New England Theatre Conference on November 1 - 3, 2007 in Waterville, New Hampshire.

Jack Wholey, Community Member, asked about the money collected in the theatre arts program. Mr. John Lidington, Hull High School Treasurer for Extra Curriculum Activities, explained the procedure used for all student accounts as follows:

- All monies collected through student activities are deposited into a single student activity account.
- Monies are input into the town accounting system
- Request for payment from individual schools are made to the business office
- All money spent is approved by School Committee
- Town accountant is requested to transfer requested funds into checking account
- Check is issued for requested items

Jack Wholey requested information from the student activity account audit. Dr. Tyrell informed Mr. Wholey he would need to make a request for information in writing.

#### 7.5 Mathematics Update – Dr. Joy Turpie

Dr. Tyrell explained that a school falls into corrective action when the entire school or sub group does not make the adequate yearly progress (AYP) determined by the state. A subgroup (free and reduced lunch students) at Memorial Middle School fell into this area and was placed in corrective action for mathematics. This year thanks to the students, teachers and parents at the Memorial School the AYP aggravate in all areas is fifty percent out of correction action. Dr. Tyrell also congratulated the previous superintendent, Dr. Paula Delaney and Memorial School Principal Andrew Stephens on this improvement.

Dr. Joy Turpie, Assistant Superintendent presented an overview of the system wide mathematics program, which included the following:

- Goals of mathematics program
  - o To provide students with access to curriculum and instruction
- Adequate yearly progress (AYP)
  - o Improvement targets
  - o In the year 2014 all students need to be in the proficient and advanced categories in English Language Arts and mathematics
- Consequences of not making AYP
  - o Year 1 School is noted
  - o Year 2 School is placed in need of improvement
  - o Year 3 School is placed in corrective action
  - Year 4 School in restructure
- Need to make AYP for two (2) years in a row to reverse a label
  - o 2006 Memorial School was in corrective action because a subgroup did not make the AYP
  - o 2007 Memorial School did make the AYP aggregate for all groups
  - o 2008 is an important year for making the AYP in mathematics at Memorial School
- Previous analysis
  - o Elementary and middle school curricula were not well aligned to move students successfully from elementary to middle school.
  - o Some middle school students did not receive mathematics five times a week
  - o Some high school students took the tenth grade MCAS before taking Algebra II.
- Changes implemented
  - o Elementary students are receiving a more gregarious curriculum (Everyday mathematics)
  - o All middle school students are receiving mathematics five times a week
  - o Last year targeted students at the middle school receive additional support
  - Many high school students presently are taking two mathematics courses before taking the tenth grade MCAS test
- Immediate goals
  - o To increase academic expectations for all students
  - o To continue to improve mathematics MCAS scores at the middle school
  - o To continue to improve MCAS scores at all schools
  - o To finish alignment in the mathematic curriculum between all schools
- Recent sequence of mathematics courses

Kindergarten – grade five
 Grades six and seven
 Everyday mathematics
 Impact mathematics

o Grade eight Algebra I

o Grade nine Geometry and Algebra I

o Grade ten Algebra II and geometry

o Grade eleven Choice of: trigonometry, topics, or honors pre-calculus

o Grade twelve Choice of: trigonometry, A/P calculus, topics,

Quincy College pre- calculus or University calculus I
