A public hearing would take place at the April 28, 2008 meeting followed by a School Committee vote on the FY09 budget.

A Community Outreach Forum will be held for the discussion of school fees on Monday, April 7, 2008 in the Hull High School Second Floor Exhibition Room at 6:00 p.m. Catherine Bowes requested information on the affect athletic fees has had on other communities.
