7.1 Café Prepay – Ms. Judith Saide and Mr. Michael Berkey

Judith Saide, MIS Director and Michael Berkey, Food Service Director, presented the following information:

- Student lunches can be paid on-line via Café Prepay
- Checks may still be used to pre-pay student lunches
- Parents can see balances in their child's account on a daily basis
- Processing fee of 3.9% with a 28¢ per transaction fee
- Payments may be made by logging onto the website and scheduling a once a month payment, paying in real time or auto replenish

Ms. Saide said a letter would need to go home to parents/guardians with instructions and student identification number.

#### 7.2 School Nurses' Presentation

Kathleen Hollingshead, R.N., Barbara Meschino, R.N., and Sharon Striglio, R.N. presented the following information on H1N1 and seasonal flu planning for Hull Public Schools:

- Focusing on the schools
- 1399 confirmed cases of H1N1 influenza in Massachusetts as of September 3, 2009
- Planning goals
- Prevent transmission of the flu
- Control and surveillance measures
- Keep sick students/staff home
- Prevention: promote H1N1 and seasonal flu vaccination

Ms. Hollinghead said that letter would be going home with students this week with information regarding H1N1 and the seasonal flu. She also said the school nurses will continue working with the Board of Health.

Teachers in grade eight have requested to also use the *History Alive* textbook. Dr. Turpie said the adoption of these textbooks would align curriculum in grades six (6), seven (7) and eight (8).
