7.0 Business Items – Superintendent

7.1 Long-Term Space Needs Update

Dr. Tyrell said that the Long-term Space Needs Committee has met three times since November 2009. The Committee has discussed past, present and future space needs.

7.2 Coordinated Program Review Update

Judith Kuehn, Director of Student Services, reviewed the Massachusetts Department of Elementary and Secondary Education Final Coordinated Program Review Report. She summarized the status areas for special education, civil rights, English Language Learners, and career/vocational education for commendable as well as for the requirements found to be less than fully implemented. Ms Kuehn also presented information on the corrective action plan that will be submitted to the Massachusetts Department of Elementary and Secondary Education. Ms. Kuehn responded to questions from School Committee.

7.3 DESE Student Growth Model

Dr. Joy Turpie, Assistant Superintendent, presented the following information on DESE Student Growth Model:

7.4 Race to the Top

Dr. Kathleen Tyrell explained that Race to the Top is part of the federal stimulus money. Massachusetts could receive \$250 million dollars over four years and must submit a grant application to the federal government to apply for the funds. Cities and towns must submit a Memorandum of Understanding to the Massachusetts Department of Elementary and Secondary Education signed by the School Committee Chair, Superintendent of Schools, and President of the Teachers' Union in order to participate in receiving funds. Dr. Tyrell recommended supporting the Memorandum of Understanding. School Committee members voiced concern that the mandates might cost more than the dollars received. Dr. Tyrell said that communities could choose to opt out at a later date if the Committee decides to do so.
