7.2 School Opening

Dr. Kathleen Tyrell reported on the following:

- Buildings were in exceptional condition and ready for opening of school
- Staff and students are enthusiastic about the opening of school
- All staff members are in place with the exception of the high school library media specialist
- Buses ran smoothly
- Lunch menus have been improved

Dr. Tyrell thanked community members for all their support to Hull Public Schools

7.3 District Goals

Dr. Tyrell said she worked with administrators during the summer to form district goals. School Committee members reviewed the district goals during their retreat on August 16, 2010. She stated that on opening day of school the entire staff became familiarized with the district goals. Dr. Tyrell read the following Hull Public School District Goals for 2010-2011:

- 1. Work collaboratively with the Hull Teachers Association in order to improve student outcomes across all grade levels.
- 2. Utilize the expertise of faculty to improve teaching and learning through peer observations and collaboration.
- 3. Complete preparations for the November 2011 NEASC accreditation visit.
- 4. Reduce the drop-out rate by identifying and working with at-risk students in grades K-12.
- 5. Provide clear understanding of the school department's budget and financial needs to the community.
- 6. Report progress on the 21st Century Schools Initiative to the community.

7. Work collaboratively with Town departments and community groups.

7.4 *Boston Magazine* Top 50 Schools

Dr. Tyrell announced that in the September 2010 issue, *Boston Magazine* has listed Hull High School among the "50 Best Public High Schools." The ranking includes information on student-to-teacher ratio, per-pupil spending, MCAS scores, SAT scores, graduation rate, percentage to college, sports teams and clubs in each of the 50 Massachusetts public high schools. She said she was proud to tell this community that Hull High School is a top-notch school.

7.5 Introduce Laura Miceli, Director of Curriculum, Instruction and Professional Development Dr. Kathleen Tyrell introduced Laura Miceli the new Director of Curriculum, Instruction and Professional Development. Ms. Miceli earned her Bachelor's degree from the University of Massachusetts. She holds two Master's degrees, from the University of Massachusetts and Boston University. She is currently a Doctorial candidate at Northeastern University. Ms. Miceli comes to Hull with a strong educational background. Her experience includes working in Brockton, Hanover and Fall River. She has also worked for the Massachusetts Department of Elementary and Secondary Education.

Laura Miceli said she looks forward to working in Hull.

7.6 Education Jobs Grant

Dr. Tyrell said that Hull Schools has received \$234,235 from a federal Education Jobs Grant. She said she met with the Administrative Team to discuss the needs of the District. The plan to use the money from this grant will balance the needs of each school. Dr. Tyrell presented the following summary for the expenditure of this grant:

7.7 Advisory Kick-off Program

Dr. Tyrell gave the following overview of the Hull High School first advisory Kick-off Day:

- On September 21, 2010 all Hull High School students will participate in an all day advisory day
- Freshmen class will stay at the high school, and will work with Principal Michael Devine on team building activities
- Sophomore students will work on community service projects throughout the town with James Quatromoni, Community Outreach Coordinator
- Junior advisories will take a commuter boat to Boston and take a guided tour of a college or university.
- Senior advisories will visit a cultural or historical site in Boston and spend at least 2 ½ hours touring the site.

Dr. Kathleen Tyrell thanked the high school administrators and staff for putting the advisory kick-off day together for the high school students.

7.8 Solicitation of Advertising

Michael Devine, Hull High School Principal, said he is not asking for a policy change. He presented the following information regarding advertising at athletic facilities:

7.10 Anti-bulling Update

Stephanie Peters said that there are no funds associated with this unfunded mandate.

Judith Kuehn, Director of Student Services, presented the following update on steps the District has taken and will be taking on the Bullying Act of 2010:

- Students and teachers collected data on where bullying incidents occurred at Hull High School
- Legal issues and consequences around bullying, stalking, identity fraud and other important harassment issues were presented to the high school student body and staff
- A School Committee Bullying policy has been drafted and is being reviewed by Attorney Mary Ellen Sowydra prior to the School Committee first reading scheduled for October 25, 2010
- John Halligan (Ryan's Story) will address students in grades 6-12 on January 19, 2011. An evening session for parents will be held on January 18 or 19, 2011
- A draft preschool grade 12 bullying incident report form has been created
- Civil rights training and information on the Bullying Acts of 2010 was presented to all staff on opening day
- Training for the Administrative Team took place on September 9, 2010
- Second Step curriculum will be taught to every student at Memorial Middle School and L.M. Jacobs School
- Professional development was provided during the summer to physical education/wellness teachers to create a unit on bullying
- Student Services staff are aware of the vulnerability to bullying, harassment or teasing because of a child's disability
- Brochures for parents from MARC has been added to the Student Services website
- Training will be provided to bus drivers
- A task force to create the Hull Public Schools Bullying Prevention and Intervention Plan for the DESE will be assembled

School Committee thanked Judith Kuehn for her comprehensive presentation.

7.11 Regionalization with Cohasset Public Schools

Dr. Kathleen Tyrell said that she and Ms. Stephanie Peters, Hull School Committee Chair met with the Cohasset School Committee Chair and Superintendent of Schools, on August 9, 2010. Dr. Tyrell stated that the parties agreed to put forth the following motion for each School Committee to consider:

To form a study committee comprised of the Cohasset Superintendent of Schools, Cohasset Town Manager, Cohasset School Committee Chair (or designee), the Hull Superintendent of Schools, Hull Town Manager, and Hull School Committee Chair (or designee) and to charge this Committee with studying the advantages and disadvantages of regionalizing the Cohasset and Hull Public School Systems and to report findings to the Cohasset and Hull School Committee by April 1, 2011.

Dr. Tyrell reported that at their September 1, 2010 School Committee meeting, the Cohasset School Committee was presented with the motion. The motion was made but not seconded. Therefore, no action was taken. There was no further discussion and no vote took place. The following substitute motion was made by Ms. Jeanne Astino and seconded by Dr. Paul Schubert:

To form a study committee to explore opportunities for purchasing, equipment, services, personnel, and utilities, but not full regionalization of the two school districts.

This motion was passed by the Cohasset School Committee.

Dr. Tyrell recommended the Hull School Committee vote on both the original motion and the substitute motion.
