# 6.2 FY15 Preliminary Budget Discussion

Dr. Tyrell told the Committee that the FY15 preliminary budget reflects the same school system as is today. Two important positions were not filled this year due to the need for a kindergarten teacher. These positions (secretary and library clerk) have been eliminated from the FY15 proposed budget. The FY15 proposed budget reflects and increase of 4.68%, an increase of \$635,000. Dr. Tyrell said that administration was prepared to come forward with a 3% budget but there was a reduction of \$200,000 in grants, circuit breaker and both the kindergarten and preschool tuition fund.

Mr. Twombly stated that the Committee is committed to continuing working with the town and Dr. Tyrell and Mr. Twombly have met with Mr. Kevin Richardson, Board of Selectmen Chair and Mr. Philip Lemnios, Town Manager. He said it is a difficult procedure but is hopeful that the school department will not have to take a step backwards. He also stated that there are a lot of steps that need to be taken before town meeting. The Committee discussed the issues and decided that the FY15 budget discussion would be a standing agenda item.

Based on current data there may be some space available and she is willing to work with the town for some of their needs. He invited the Capital Planning Committee to a future School Committee meeting where the school department will present facts and the Capital Planning Committee can present their facts. Dr. Tyrell added that it will be a long process.
