6.1 Transportation Policy

James Lampke, Esq., Town Counsel and Mr. Matthew Gillis, School Business Administrator brought forward the updated policies related to student transportation. Attorney Lampke added language to protect the town from lawsuits adding that the policy indemnifies Committee members past, present and future. The Policy makes it clear that parents need to understand that parents and/or students driving to events is not sponsored by the school and it is up to the students not the school. Dr. Tyrell said that the issue arose when the Junior National Honor Society hired a school bus to take a small group of students to an event and the bus cost was half of the \$700 raised to attend the event.

The Committee asked questions and discussed the issue. Mr. Twombly asked that parents pass a CORI and that should be stated in the policy. Mr. Hipp stated that he thought the

policy was very broad and that parents may not understand it. He said he liked the idea of having a policy to allow for other than school buses for small amounts of students when there are plenty of adults willing to drive but he would like to try to simplify the policy. Mr. Gillis will bring the policies back to the next meeting with edits that were discussed, with track changes. Attorney Lampke will be bringing the policy to our insurance company for review.

Ms. Judith Kuehn, Assistant Superintendent discussed the response to data.

The Committee discussed the MCAS results. Ms. Kuehn said that the grade 6 mathematics textbook pilot program will help at the middle school level and she is working to get 2 MCAS tutors at the Jacobs school and 5 before or after school English/math tutors at the middle school. She also said that there is an academic improvement grant in grade 8 for afterschool help. Mr. Hipp said that he wants a better understanding of what is happening at the middle school. Dr. Tyrell said she appreciated the interest and will get back to the Committee at the next meeting.

There are several other communities already doing this and the Superintendent believes that we could offer a safe program and put parents at ease and would be less stressful for parents. Ms. Peters thought it would be a great idea to offer to all town employees. Dr. Tyrell said that school employees would be considered first but it may be able to be opened up to town employees in year two. She concluded that she would continue on with plans and come back to the Committee with updates.
