The meeting of the Hull Board of Selectmen was called to order at 7:38 pm on Tuesday evening, December 2, 2008 at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts

7:30 pm – Tax Classification Hearing

David Beck, Assistant Assessor and members of the Board of Assessors were present for the annual tax classification decision by the Board of Selectmen.

Beck stated that the Assessors voted to recommend the Selectmen vote not to approve the four the four questions as follows: 1. Residential Factor; 2. Open Space Discount; 3. Residential Exemption; 4. Small Business Exemption.

The Members praised David Beck for being selected for one of only two awards across the nation with 300 applicants. Beck was responsible for developing a video educating residents on filing abatements shown on the computer. The video was technically produced by Pam Kaufman, a member of the Board of Assessors.

7:45 pm – Robert Fultz – re: Community Development Block Grant for FY09

Robert Fultz, Community Development Director and Town Planner said he intends to follow the existing program that has a target area from M to Malta Streets by extending it north of M Street to T Street, and to Kenberma and A Streets. He said he expects to have a hearing with the Selectmen in January.

8:00 pm – Library Trustees – re: Library Construction Project

Present were Daniel Johnson, Library Director and Trustees Virginia Cap, Teresa Ann Brady, Tommye Reede, Kathy Lacey, and Eileen Beaszley, who gave a power point presentation.

Beazley spoke about the \$2,809,680 State Grant authorized to the Town for the construction of a new library on town-owned land at the corner of M Street. In addition to having added room and parking she cited the location as being much more available to the public than the present library in an historic Hull building in the village. Beazley said the grant would issue in two phases, and the cost to the Town for a 17 – year bond for \$4 M. that she estimated would cost each household \$80.00 per year. She added that the Hull Public Library fund has raised \$125,000 and they are attempting to raise a total of \$300,00. She made it clear that there will be no actual expense to the Town for at least one or two years.

In response to a question of an override from Jim Tobin, Advisory Board Member, both Meschino and Lemnios made it clear to those present that regardless of a successful vote it is the Selectmen that must ultimately approve an override being present to the voters.

TOWN MANAGER

1 Daley & Wanzer Lease

Lemnios informed the Board that the present lease of XY Street land to Daley & Wanzer will soon expire and that the Town needs to prepare an RFP. He added that the current lease is 10-years and that they have been good tenants. The leasing fee has been \$10,500 per year plus plowing the XY Street lot and streets, and that they have a significant interest in renewing.

2 Memorial School

Lemnios suggested that it might be feasible to consolidate grade-structures at the Memorial School, Jacobs School, and High School and create a center using the space for various town functions. He said it is a concept in the embryonic stage but should be explored, and he suggested that the Chairman of the Selectmen and School Committee meet to put together a committee to look into the possibility as there are several issues having to be clarified such as various legal matters, functions and capital.

The Board recessed at 9:16 pm and returned to open session at 9:25 pm.
