

Hull Board of Selectmen
Minutes
May 17, 2011

The meeting of the Hull Board of Selectman was called to order at 7:34 pm on Tuesday evening, May 17, 2011, at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Domenico Sestito, Chairman; John Brannan, Clerk; and Chris Oliveiri, John Reilly, and Kevin Richards, members. Also present were: Philip Lemnios, Town Manager and James Lampke, Town Counsel.

7:37 pm: Charlene Tyson, not seeking re-appointment to the advisory board. She briefly spoke about what happened at Town Meeting and how disheartened she was with what happened. Urged the new board about what needs to get done, to put aside the nonsense and work toward accomplishing what needs to be done, it is just a distraction. Reilly responded and thanked her for her many years of service to the Town and spoke about how professional she is. Sestito spoke about Town Meeting and how it went. He spoke about Lampke's resolution and put it to the board to adopt the resolution.
