Hull Board of Selectmen Minutes March 8, 2011

The meeting of the Hull Board of Selectmen was called to order at 7:30 pm on Tuesday evening, March 8, 2011, at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Domenico Sestito, Chairman; Dennis Blackall, Vice Chairman; John Brannan, Clerk; and Christopher Olivieri, John Reilly, members. Also present were: Philip Lemnios, Town Manager and James Lampke, Town Counsel.

Appointments

8:18 pm: Budget Discussion

8:19 pm: At this time the School Committee and Advisory Board called their meetings to order with a second by Kevin Richardson.

A lengthy discussion took place with Lemnios going through the Town Manager's Budget, explaining that the Governor released the budget and state aid is coming very close to the town's estimation of what would be received. Addressing questions from both Blackall and Brannan, Lemnios explained that the budget reflects the lowest baseline of government services (police, fire, public works). Blackall asked the school committee about their budget request of \$13.1 compared to the Town Manager's \$12.8. Scholl Superintendent Tyrrell explained that at the time they submitted their budget it was a level service budget. At the end of last year the school committee did return \$142K to the town that went into free cash. Olivieri asked what the programs are reflected in the \$300K. It was explained that the programs have not yet been identified, but it prevents the cuts from being deeper. Reilly talked about items that had been

talked about being put on hold, the 58/42 split in the budget and PILOTS. If a member of the Board wants something to be added there should be a comparable cut in the budget somewhere else, suggesting the Board go by the rules that are followed in Town Meeting. Brannan would like to find out within all the various areas what the total cost is in each are, and would like to touch base on the Seniors and Veteran section of the budget. When Blackall brought up the possibility of having less money sometime in the future, Lemnios explained that discussion would have to be revisited. Resident Patrick Finn asked what the payments are now on Memorial School. Lemnios explained that the Bond is a 20 year bond and there is roughly ten years left. Charlene Tyson of the Advisory Board asked what the credit rating is and Lemnios said he believed it to AA rating.

9:39 pm: a brief break was taken at this time

9:45 pm: meeting resumed

9:47pm: Advisory Board adjourned, they no longer had a quorum

Sestito began by recognizing the late hour and asked Blackall if he would be comfortable continuing these topics at a later date. He agreed yet felt it important to discuss school budget numbers. Blackall asked if at the next meeting there will be a vote on at least three of the items (stabilization, PILOTS, 2 1/2 increase) in order to allow the School Department and Advisory Board to make their budgets and reports. School Committee Chair StephaniePeters offered to come back, but they are here and would like to answer questions - preferably this evening. The discussion turned to the teachers contract and what the implications of that contract are. Sestito suggested that they postpone the discussion to a later time. Reilly suggested a non-Tuesday meeting. March 14 at 7:30pm was agreed upon.
