The meeting of the Hull Board of Selectmen was called to order on Tuesday evening, October 11, 2011, at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts.

Mr. Gainor appeared before the Board to introduce himself and speak of his experience.

7:45 Richard Miller, Light Company Operations Manager – Update on Light Company

Miller told that Board that they have very few outages, the biggest one was due to the feed from National Grid. He has met with Representative Bradley and Representatives from National Grid will meet next week for a walk through of that line. They told Mr. Miller that they will have an action plan in place by the end of November the beginning of December. Brannan asked if Hingham used the feeder because it goes through that Town. Hingham does not use it because they have a main line that goes directly to their sub station. Miller said it would cost about 4 million to install a new line. Discussion continued between the Board, Miller and the audience.

Brannan asked for an update on the wind turbines. Lemnios gave a brief update to the Board, Hull Wind I has a 16% return on investment while Hull Wind II is 6%. Hull Wind II cost more than Wind I.

Brannan asked Lemnios to update the Insurance, GIC and the States position on it. The State is allowing Towns or groups to alter Health Insurance plans. He told the Board that Hull is a member of the Mayflower Group. The group is still at the beginning stages of figuring out how to address this because of the steps that one needs to go through. Mayflower Group is doing an analysis at this time.

Reilly asked Lemnios to update the progress on the Pemberton Float. An RFP is out for repairing the float. Lemnios is working with the MBTA to see if a temporary float can be installed so service will not be interrupted. The repair work is expected to take about 90 days.
