## **APPOINTMENTS CONT.**

Robert DeCoste, Chairman/Parking Study Committee was added to the agenda this evening and would like to speak to the BOS for some clarification.

Last year, the committee was discussing the Menice Field and L Street parking issues. They came up with a complex signage which was for "field-use only." The police while working with this matter, do not think it was the best way to have it. What they came up with was simply to designate both the parking lot at Menice Field and the spots along N Street have "field-use only" with violators subject to be ticketed. DeCoste is here at the Board for clarification and to make it work. The sign in those fields did work for everyone.

period from July 1, 2013 to June 3, 2014.

DeCoste then spoke of a pilot program for plaque parking at the War Memorial on Samset Avenue. The Parking Committee, in discussing this looked at the changes of regulations involved. One of the items the Committee looked at was to remove the meters completely and make those leveled spots to be municipal spots so that any resident in town with a resident's sticker that wanted to go to the beach would be able to use those 11 spots as opposed to having a 2-hour limit and be ticketed. They discussed this idea with the police department, which was supportive. The motion passed unanimously by the Committee.

Motion - Sestito: To approve the 11 spaces across from the war monument from May

15, 2013 to June 30, 2014 to keep as municipal parking only.

# 8:30 p.m. – Lenore White – re: N. Truro Street

White addressed the BOS on behalf of William Horne of 21 Berkley Road, Hull, MA. Wetland Strategies, Inc. is requesting to discuss the proposed extension of N. Truro Street to a lot owned by Horne (Lot 47-022). According to Town Counsel, the Town has jurisdiction over a portion of the road in this area. In order to extend the roadway to Mr. Horne's lot, the Town must agree to the extension on the part the Town has jurisdiction over. In addition, Horne intends to apply for an Order of Conditions from the Hull Conservation Committee of said roadway extension. They are here this evening to seek the Town's signature on the Notice of Intent they want to file, as the Town's signature is needed due to the Town's jurisdiction over part of the road they propose to work in. Lampke explained that tonight is just for the signature of the NOI and that there would need to be separate authorization sought at a later date for the actual work in the portion of the road over which the Town has jurisdiction. White presented a draft NOI and a new plan showing the road. White verified that the work for the road extension was solely in the area under the Town's jurisdiction. She said that she needs to file the NOI by Thursday in order to meet a hearing schedule and would bring to the office for signature the final NOI. Lemnios stated he would not be in on Thursday. Reilly said that he would come by to sign it if necessary. Lampke had suggested language for the Board's motion tonight.

Motion - Olivieri:

Move that the Board authorize the Chair or Town Manager to sign onto the Notice of Intent pertaining to North Truro Street presented by Wetlands Strategies, Inc. on behalf of the Horne property, with the understanding that: (1) the signing by the Board only relates to property under the jurisdiction of the Town; (2) is for the purpose of enabling the Notice of Intent to be filed; (3) does not constitute endorsement of any proposed work; (4) is not a grant of authority to

perform any work on property under the jurisdiction of the Town, which must be separately obtained; and (5) all rights and remedies of the Town are reserved and not waived.

Second - Richardson

Vote - Unanimous in favor
