July 10, 2013

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Wednesday evening, July 10, 2013 at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts.

Present: Kevin Richardson, Chairman, Domenico Sestito, Vice-Chair, Dr. Christopher Olivieri, Clerk, John C. Brannan, and John D. Reilly, Jr., Members. Also present were: Philip E. Lemnios, Town Manager, James Lampke, Town Counsel and Karen Morgan, Recording Secretary.

The Board held a moment of silence in memory of the passing of Gordon O'Brien. He was a decorated WWII Army veteran of D-Day and the Battle of the Bulge who attained the rank of captain. He was awarded a Purple Heart, Bronze Star, five Battle Stars and most recently the French Legion of Honor at a ceremony before the Board of Selectmen with representatives from the French government.
