The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Tuesday evening, December 3, 2013 at the Hull Municipal Building, 253 Atlantic Avenue, Hull, Massachusetts.

APPOINTMENTS

7:30 p.m. – Anne Herbst – re: Conservation Office Activities

Herbst along with Ellen Barone presented to the BOS her presentation of the Conservation Office Activities.

The following topics include:

Massachusetts Wetlands Protection Act

- Administration of the WPA is the primary work of the office. WPA is a state law all timelines, requirements and standards are set by state law and regulation
- Permitting is done locally by 7 member citizen volunteer commission, appointed by the BOS
- Any appeals of commission decisions go to state DEP

Hull WPA jurisdiction

• If a project requires digging or altering the ground or water flow, a permit is needed. New buildings, additions, revetments, piers and paving a driveway may all require permits. Any interior work on a house would not. Please note need to check with the Conservation Office before starting work

Eight Interests of WPA

- Why our wetlands are protected; it is not for aesthetic value or esoteric reason
- Wetlands are regulated only to the extent that they protect one of the interests identified in the *law*
- Coastal dunes are protected because they serve the interests of storm damage prevention and flood control
- A salt marsh protects against flooding and storm damage and the pollution from reaching coastal waters and protects fisheries and shellfish
- Paving a driveway may not need a permit because it can have an effect on flooding to neighboring properties

- Blocking a view to the water would not be regulated because it does not involve one of these interests
- The Commission's job is to figure out what wetland areas are involved.

Efficiency + Education = Better Outcomes

- The goal is improving compliance with the law to protect our wetlands
- Hope to improve the permitting experience and encourage cooperation with the following steps: Commission changed procedures so that permits can be issued in the minimum time allowed by law, Streamlined permitting of minor projects, Provide applicants with help on state forms, Created a post-permit handout, Coordinated permitting with Building Dept. to avoid unnecessary enforcement.
- Send primer on the law to new home owners each month
- Send mailings in the light bill
- Provide education on special topics (protecting coastal banks and the dunes)

Freeboard Incentive

• In 2009 the BOS approved a program to rebate \$500 to building department fees for properties that elevate 2 ft. higher than required by flood map and building code
