7:30 p.m. - Veterans Monument Grant Approval

J. Coggins and E. Burke spoke to the BOS about the Veterans Monument Grant Approval. Coggins invited the public to the 9:00 a.m. Memorial Day parade, also from 9-11 on May 24th anyone can participate in the placing of flags on memorials. Burke stated that the 540 names went up on the North side of the monument and they missed some names so with phone calls and letters and came up with 31 names from WW1, 62 names from WW2, 53 names from Korea and 10 names from Vietnam and they are in the process now of finalizing the list and getting plaques and having another ceremony. The grant that Bill Leamy found from Veteran's Service that will be applied for and they are looking for support from the BOS. The grant needs to be in by May 30th. Lemnios said that this is the FY2014 War Memorial Grant coming up. There is a \$100,000 statewide (\$20,000 for the South Shore, \$20,000 for Central Mass, \$20,000 for Western Mass, \$20,000 for North Shore). It is a competitive process. It is a matching grant and we do have our share of the match.
