## 7:30 p.m. – Aquarion Water – re: Grant of Location on Montana Avenue

Ronit Goldstein, Community Relations Manager and Stephen Olson, Sr. Project Manager spoke to the BOS about Aquarion planning to install a new water main on Montana Avenue beginning at the intersection of Montana Ave. and Atlantic Ave. and terminating at the end of Montana Ave. The installation of this main is expected to occur in the Fall of 2014. The anticipated duration should take about 2-3 weeks.

B. Stacey, 5 Montana Ave asked Olson to see the plan in which Olson provided to him and also if dynamite will be used like the last project. Olson said it would depend upon further review by the contactor if blasting is required.

# 7:45 p.m. - Logan Airport Committee - re: Update

David Carlon spoke to the BOS about the updates from the Logan Airport Committee. The objective is to reduce noise and air pollution as well as increase safety. The progress update included researching issues, coalition building, CAC participation and engaging state and federal legislators. Areas that have since changed are the economic rebound, flight plan changes, changing demographics and values, community activism, increased runway extension, and growth of Logan Airport. The achievable nearterm solutions include fairness in load balancing, keeping distance from residential land and making noise mitigation a priority. The proposed actions are to meet with Massport officials, continuing evaluations, focusing on implementing near term solutions. The presentation can be seen on the Hull Town website. There is also a new FaceBook page created with further information.

In a letter from the Billings to Olivieri dated Aug. 26, 2014, he wrote of the Hull Police Dept will be joining 182 MA police agencies to issue Taser Devices to their officers. The Hull Police Dept. have developed a policy on the Taser which was approved by the Executive Office of Public Safety and Security. Tasers afford officers an opportunity to de-escalate a potentially violent and dangerous incident without utilizing lethal force tools in an effort to maintain public safety and officer safety.
