CORRESPONDENCE

<u>Read aloud</u> by Olivieri correspondence from Hull Historical Commission re: Historic Plaque
In a letter from Fulvia Matteucci for the Hull Historical Commission to the BOS dated August 27, 2014,
the Historical Commission is requesting the approval for the Town of Hull to approve a dedicated account
for the historic preservation plaques.. The Historical Commission is in the process of preparing historical
houses and other buildings for the Plaque Program. Owners of houses at least 75 years old will have the
option of purchasing a distinctive and town uniform historic plaque. As part of the program, the
Commission will need to collect money for the plaques from home owners.
