#### Minutes

#### **April 19, 2016**

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Tuesday evening, April 19, 2016, at the Hull Municipal Building, 253 Atlantic Ave., Hull, Massachusetts.

Present: John C. Brannan, Chair; Domenico Sestito, Vice-Chair; Christopher Mitchell, Clerk; John Reilly, Jr., Member; and Kevin Richardson, Member. Also present were Phillip Lemnios, Town Manager; James Lampke, Town Counsel; and Catherine Goldhammer, recording secretary.

#### **APPOINTMENTS**

## Craig Wolfe regarding Nantasket Beach Car Show

Craig Wolfe was present at the meeting to update the board on the upcoming annual Nantasket Beach Car Show to be held on Sunday, June 12. The car show raises money for Cops for Kids with Cancer and also for two Hull scholarships.

#### Mike Buckley regarding authorization to proceed with borrowing

Town Accountant Mike Buckley asked the board to authorize the town to begin the process of borrowing to fund the Crescent Beach Seawall project. This is a borrowing for a \$1.5 million subsidized loan at 2% for 20 years. The selectmen voted as follows and signed the documents.

#### Follow-up request from Representative Bradley regarding Fort Revere

The selectmen discussed a communication from Representative Bradley seeking to confirm the town's intent regarding the Special Town Meeting vote on Fort Revere and the 1998 land swap legislation. Bradley's office would like to confirm whether the town would like him to pursue the initial conditions of the legislation, or to state its wish to turn over the lands at Fort Revere to the DCR for use as a state park. Robert DeCoste, member of the HRA, spoke about an exchange of parking parcels at the HRA site (the DCR parcel for the HRA parcel at Phipps Street) which the HRA is pursuing with the DCR. Lampke had sent to the Board suggested language.

After discussion, the board voted as follows on a motion by Sestito and including an amendment by Richardson:

However, following a discussion of Article 13, regarding a cost of living increase for retired town employees, Reilly stated that he had voted in favor of this article at an earlier Retirement Board meeting. He made the following motion that the selectmen support the article, but withdrew it when Lemnios suggested that Town Accountant and Retirement Board Chair Michael Buckley would make the motion presented to Town Meeting more specific.
