Joan Meschino regarding letter of resignation

Meschino notified the board that she is resigning as the Board of Selectmen's appointee to the Metropolitan Area Planning Counsel and the MBTA Advisory Board. She will also be resigning from the Capital Outlay Committee. Reilly suggested that before advertising for a replacement, the board should consult with Town Manager Lemnios about whether the new town planner would like to assume those positions. Meschino was recently elected as Hull's State Representative.

John Struzziery regarding letter of resignation

John Struzziery notified the board that he is resigning from the Permanent Sewer Commission. He will be assuming a position with the town as head of the Sewer Department.

The board will send letters to appreciation to both Meschino and Struzziery for their past and continued service to the town.

NEW BUSINESS

Sestito thanked Mitchell for attending this month's HAPSA meeting in his place. He stated that the group has put together a survey to learn what activities the community would like to promote in efforts to help fight the opiate epidemic. He requested that the survey be posted to the town website.

Sestito also stated that he wanted the public to be aware that school has reported that there is a potential state funding cut for the school resource officer. He noted that Superintendent Tyrell and Town Manager Lemnios are working to advocate keeping grant funding for the position and have reached out to the town's delegates and to the Governor's office.

Resident Rhoda Kanet asked if there has been any follow-up to the DCR regarding the Nantasket Beach seawall proposal and whether the town has any recourses. Richardson stated that Lemnios is working on a response and this will be on the agenda for an upcoming meeting. Reilly noted that there was a 15 day comment period and suggested that the town post the comment website link on the town's website.

Kanet also announced that there will be a Menorah lighting on Monday, December 26 at 5 p.m. at the War Memorial gazebo. There will also be two Martin Luther King Day events: a breakfast at St. Nicholas and a dinner and movie at the temple.

The meeting was adjourned at 7:57 p.m. The board will meet next at 7:30 p.m. on Thursday, January 5, 2017.
