Minutes

September 22, 2016

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Thursday evening, September 22, 2016, at the Hull Municipal Building, 253 Atlantic Ave., Hull, Massachusetts.

Present: Kevin Richardson, Chair; Christopher Mitchell, Vice-Chair; Domenico Sestito, Clerk; and Jennifer Constable, Member. Also present were Phillip Lemnios, Town Manager; James Lampke, Town Counsel; and Catherine Goldhammer, recording secretary. John Reilly, Jr., Member, was not present.

Richardson congratulated Firefighter Jay King on his retirement after 33 years of service.

APPOINTMENTS

Logan Airport Committee Update

Dave Carlon, Chair of the Logan Airport Committee, updated the selectmen on the committee's activities since it last came before the board.

Carlon noted that there has been an increase in air traffic noise, particularly in "primetime" hours, during which it is significantly more persistent than in the past. He also stated that there are now complaints occurring nationwide from areas that have been affected by the new flight patterns, and that the FAA is therefore more open to the idea of making changes. He further stated that Hull is in a unique position to achieve remediation because of its location and the possibility of directing some of the traffic over water rather than over the town.

Numerous residents were present at the meeting to voice their concerns about the effects of noise on their lives, stating that the volume of the noise is overwhelming and negatively affects their well-being.

Carlon asked the selectmen to endorse the committee's recommendations, which include alterations to flight paths and runway usage. Richardson asked for a motion to endorse the Logan Airport noise relief recommendations as presented: regarding departures, to request that planes departing Runway 22R and 15R be shifted further from Hull's shoreline and over the Boston Harbor Islands on a pre-2012 flight track; to ask for relaxation of the three nautical mile flight path separation rule; and regarding arrivals, to ask that whenever feasible, Logan arrivals that might otherwise use Runway 33L be routed, instead, to a flight path with continuous descent over the Atlantic Ocean and Boston Harbor, preferably north of Boston Lighthouse.

Appointment of two permanent full time police officers

Chief Sawtelle also asked the selectmen to approve the appointment of two full-time police officers, Steven P. O'Neill and Leanne N. Marshalsea. The appointment of these two officers would require the board to first authorize the department to by-pass the first name on the certified roster. Town Counsel Lampke explained that the first person on the list has not been able to complete the police academy and without adjustments from the academy, which it is not permitted to make, he will not be able to do so.

Richardson asked for a motion to approve the by-pass of the number one candidate on the list for the following reasons:

- Failure to successfully complete the academy;
- Candidate did not have a reasonable expectation of completing the requirements of the academy;

- Candidate does not appear to have the ability to perform the state established and reasonable requirements
 of a police officer in that he cannot adequately run, which is a requirement to successfully complete the
 academy;
- Candidate was less than forthright in his representations to the police chief as to his preparations for the academy and to the academy as to his fitness and his ability to do what is required;
- Candidate displayed a lack of ability to follow instructions.

And to further move that the board appoint Officer Steven P. O'Neill and Officer Leann N. Marshalsea as permanent full time police officers.

NEW BUSINESS

Lemnios spoke about the September 12 meeting held with the DCR Commissioner. The Hull Redevelopment Authority was present, as were Selectmen Richardson and Mitchell. Lemnios described this as a very productive meeting and stated that the Commissioner seems very open to exploring resolution to long-standing issues, in particular the proposed parking lot swap with the HRA. The group toured the HRA property, visited the Pt. Allerton seawall, Fort Revere, and Pemberton Point. Lemnios stated that the Community Compact, which is a partnership between the town, the HRA, and the DCR is something that the state is still very interested in.

Lemnios also informed the board that an offer of employment has been made to one of the candidates for Director of Planning and Development, and the town is near making a decision on a Conservation Administrator. Police Chief interviews will be held in a few weeks.

In addition, Lemnios noted that the town has received notification that it has been approved for the next stage of its Complete Streets application and was awarded \$38,000 for assistance with a prioritization plan. He also said that a

set of playground equipment was received via donation and will be installed at the Kenberma playground in October. He thanked Greg Gray, who was instrumental in acquiring the donation.

Sestito thanked everyone who attended and organized the 9/11 ceremony. He also noted that he had received a letter regarding a traffic issue on Main Street.

Constable said that the South Shore Vocational Technical School Committee had a site visit and informational meeting at the South Shore Vocational Technical School. She also noted that Hull athletic schedules have been posted.

Richardson noted that two documents had been received from the School Committee regarding charter schools. He also suggested that a meeting with the Capital Outlay Committee be put on the agenda.

Resident Rhoda Kanet said that the recent Coastal Sweep collected 240 pounds of trash. Kanet further requested that the appointment of a zoning bylaw study committee be placed on the agenda.

Richardson asked for a motion that the Board of Selectmen call for a special local election on November 8, 2016 for the purpose of seeing if the town will accept the provisions of sections 3 to 7 of chapter 44B of the General Laws, commonly known as the Community Preservation Act; and that the town request the Governor to file a Governor's Message for said election.
