March 2, 2017

The meeting of the Hull Board of Selectmen was called to order at 7:30 p.m. on Thursday evening, March 2, 2017, at Hull Municipal Building, 253 Atlantic Ave., Hull, Massachusetts.

Peter Pyclik regarding application to serve on the Permanent Sewer Commission

Robert DeCoste regarding HRA land swap

Bartley Kelly, Chairman of the HRA, and Robert DeCoste, Vice Chairman of the HRA, were present at the meeting to update the selectmen on discussions with DCR Commissioner Leo Roy about the proposed parking lot exchange between the DCR and the HRA. The two parking lot parcels are both 1.46 acre lots. In addition, the DCR would like the HRA to give them .72 acres on the beach and the town to transfer to them .07 acres on the beach.

Town Counsel Lampke said that he would research how the town acquired that land in the beginning and whether or not the exchange would require Town Meeting approval. Lemnios said that a placeholder would be put on the warrant. He pointed out that the goal is to create as much contiguous land for the HRA as possible and the general concept is one that the board has supported in the past.

Reilly asked how the exchange would affect the development of the HRA property. DeCoste said that the bids on the property will be opened on April 3.

The HRA will continue its negotiations and return to the board at its March 16 meeting.

Police Chief Dunn, re: Presentation of Beach Avenue (one-way

In a response to a previous request by the board, Police Chief John Dunn presented the department's findings on the matter of whether to make Beach Avenue one-way from A Street to L Street. Dunn stated that the department had conducted a safety review, a speed study, and a cost review. Dunn's presentation can be found in the archives of this meeting. It considered such factors as:

- Cost of signage;
- Cost of painting for bike lane;
- July 15 speed study which showed an average of 753 vehicles per day, or 31 vehicles per hour, over a 24 hour period for 7 days;
- Average speed of 21 mph, with 95% traveling 30 mph or lower and no clear need to adjust current speed limit of 30 mph;
- Two accidents in the past five years, both in 2013 and both non-life threatening;
- Bike lane requiring a lower speed of 25 mph;
- Potential impact on traffic flow and speed.

Dunn noted that a negative factor is that speeds tend to increase on one-way roads. Based on these factors, Dunn stated that it was not his recommendation to make the change to a one-way street.

Scott Beard, Beach Avenue, stated that safety is a problem on the road. He asserted that it is not wide enough, and that parking and dune encroachment reduce the width further. He noted that there is heavy pedestrian traffic and it is hard to see people coming out of the dune. He stated that the accident history shouldn't be the determining factor and asked if there have been speed studies in the part of Beach Avenue that is currently one-way, from Phipps Street to A Street. He said that the 30 mph speed limit is too fast and suggested that there be signs warning drivers of pedestrian traffic and dune crossings.

After discussion about options beyond making the street one-way, Lemnios said that he will work with the department and create a list of possible ways to relieve traffic and improve safety concerns at crossing points.

The board took a five minute recess.

Discussion of 2017 Town Meeting Warrant

The board discussed the Town Meeting draft Warrant, beginning with a discussion of an article proposing to remove the Police Department Captain's position from Civil Service. [Note: Selectman Reilly recused himself from this discussion and was not present in the room while it was being conducted or voted upon.]

Chief Dunn stated that moving the position out of Civil Service would help the town get a wider and deeper field of candidates and allow the best person to be chosen for the job. Lemnios noted that the article is a prospective action and would not affect the current captain.

Discussion Economic Development Committee

Constable asked the board to support the creation of an Economic Development Committee with the goal of promoting economic development in town. She suggested members from the Planning Board, the HRA, the Board of Selectmen, and the Chamber of Commerce, as well as Director of Planning and Community Development Chris DiIorio and members of the business community. Constable will put together a document with the proposed makeup and charge of the committee and the board will discuss at its next meeting.

Lemnios updated the board as follows:

- There was a ferry accident at Pemberton Pier and Boston Harbor Cruises will repair and reinstall the dock. There is no interruption in service.
- The street sweeper is out early due to favorable weather.
- The Advisory Board has started its budget review process and is meeting on Mondays.

- The town is still pursuing the Atlantic Avenue TIP project and Lemnios attended a recent meeting on the project. He noted that the state seems to be giving attention to smaller communities as well as larger ones.
- Department head meetings on the social media policy are ongoing.

The meeting was adjourned at 9:53 p.m. on a motion by Sestito, seconded by Mitchell. The board is scheduled to meet next at 7:30 p.m. on Thursday, March 16, 2017.
