Report on WRWA Auction March 30

Congratulations to Courtney, Samantha and all their helpers who helped make this fund raiser a tremendous success. The figures provided are only an estimate as additional money is still coming in.

- Courtney reports that event grossed about \$15,000
- Approximately \$2K in expenses, \$9K came in from auction items, \$5K in ticket sales and donations and \$1K from advertising. The net income to date is likely to be about \$13,000!!
- Many new members were signed
- Courtney's neighbor, Dino, is donating a gift of hardwood floors and installation labor for the Estuary Center!!

Publicity:

- The *Hull Times* had a photo caption. A thank you letter is expected this week.
- It was unclear if Hingham and Cohasset had any write-ups. Kirk Shilts was coordinating this.

Lessons Learned:

Access Policy for Land Protection Plan

Review the Access Policy for the Estuary Park and include as an appendix.

Discussion:

- Item H: "limit footpaths to neighborhood and educational use" was a primary topic. Scott was concerned that a park should not exclude foot traffic. Judeth provided a historical perspective on the intent. "Water is the Path" and roadways provide the means to view the estuary. Local property owners were strongly opposed to pedestrian access through neighborhoods. This was primarily in the area around the Hall Estate to the Landfill section.
 - In the early 90's, Gateway East was once proposed for a multistory housing project. Townsend proposed a 'park' and plans for a perimeter boardwalk were developed. Neighbors were not friendly towards a boardwalk.
 - Hull recorded a 10' easement around the border of the Hall Estate.
 - In the Weir R. Woods, the entries to trails have been blocked to discourage misuse of Woods.
 - Thus "water is the path" and "use road right-of-ways as paths."
 - It was discussed that Gateway West makes a better location for a footpath connected to the Estuary Center.
 - Any footpath should be weighed for its impact on wildlife.
 - Rather than use restrictive wording, Item H was removed from the Policy.
- Item M: Faith expressed concerns that storm water collection makes it dangerous and impassible to use certain sidewalks. Item M was removed as is covered by Item E "make the roadways pedestrian friendly".
- Scott will revise the Access Policy and send the revisions to the group.
- The vote on the Access Policy will be taken at the May meeting.

- Scott will contact Jake's father and determine a date for this ribbon cutting event.
- Dick has a resource for creating a plaque and will compose a few words of recognition and thank you from the committee.
