Minutes

Community Presentation of Estuary Land Protection Plan

Hull:

- Scott will make an appointment to present the Land Protection Plan to the Hull Planning Board.
- Judeth will make an appointment to re-present the Land Protection Plan to the Hull Selectmen.
- Working with the Conservation Commission, we will arrange neighborhood meetings with Sunset Point, Nantascot Place, Rockaway, and the Landfill neighbors.
- Judeth will make an appointment to present to the Hull Sewer Commission.

Hingham:

- Faith has discussed the Land Protection Plan with the Hingham Conservation Commission, Planning Board, Harbor Committee, Open Space Committee, Zoning Board of Appeals, and Sewer Department.
- Faith is working on support from the Community Preservation Committee for acquisition of the Amonte land along the Weir River.
- Faith wrote a report on the Weir River Estuary Park Committee work for the Hingham Annual Report. A map of the Estuary was on the Annual Report back cover.
- The Hingham presentations focused on what was important to each board and current projects. Faith will send Judeth a sample presentation outline.

Web sites:

- Faith and Judeth will arrange to put the Land Protection Plan, with a summary chart rather than detailed charts, on the Hingham and Hull web sites.
- Dick will arrange putting a link on the Cohasset sites.

Cohasset:

- Dick uses the Land Protection Plan as an example of preservation efforts for the Open Space Committee.
- Dick will meet with the Conservation Committee in June.

Hingham:

- Faith's next step is to put the Land Protection Plan on the web. She gave copies of the plan to all committee members.

- Faith will prepare an amendment to the Plan adding information on Hingham's special permit for cluster zoning.
- Faith suggested that we show Foundry Pond as an access point in the Land Protection Plan. She will bring this idea to the Weir River Watershed Association board.

Judeth will print two full copies of the Land Protection Plan for the Hingham and Hull public libraries.
