The Chief and Captain were happy to be in attendance to talk about the parking issues within the community.

John B gave an overview as to where the committee is in regards to many different issues.

Members introduced themselves to the Chief with their neighborhood. Chief commented on the need to springboard from the last Parking Committee report.

Chief reviewed Parking Regulations for the committee.

155-20 Parking Permit-specific parking in front of residence (only a few have been issued).

There is a two sided document that refer to the Parking Regulations that everyone should review.

Lots of history regarding the Restricted Sections of town as well as landlocked homes that have no parking whatsoever.

The Chief and Captain's one immediate action (if possible)

Duxbury they pay \$60 per year for beach lot parking

Marshfield pays \$30 per year for beach lot parking..increase the fees.....

They presented their Parking Fee Proposal presented to the Board of Selectmen....it is a power point presentation.

A review of submitted questions from the committee members followed:

Possible parking spaces along Rockland House Road and Park Avenue.

Would the Police Department allow for Parking Attendants that would supplement the summer police?

If curb cut would be put at Horizon's so that more revenue could be generated due to a permit for fee parking, would that be possible?

What is your opinion about making the entire town a restricted zone to manage the out of town visitors who consume our parking? Makes it easier to enforce according to the Chief.

Police Chief would like the Parking Clerk to report to the Police Department.

Stickers can be issued for any type of vehicle.....RV's Trucks, any registered vehicle.

Residents should be able to get as many visitor passes that they want, as long as they want to pay the price. The Chief indicated that would not be such a challenge.

Tickets can only be given 1 time a day. If at a meter more than one ticket can be issued.

\$50 is the maximum fee for a general parking ticket.

\$100 is the fee for a ticket due to illegal handicapped parking and there is a list of all these fees.

1755 Restricted Parking Stickers were purchased.

2500 Municipal Parking Stickers were purchased

3300 Visitor passes were purchased

There are 9500 cars registered in the

Stickers only have the vehicle registration on the decal

Business areas are treated separately to ensure employees do not park in parking spaces used for customers.

The committee will be asking Phil Lemnios to give us the details on how many tickets were issued, how many were appealed and how many were voided.

The Police Department pays \$400 for each meter head. \$1,200 for a complete meter with pole and install.

\$16,000 is the cost of a single pay box that has been talked about for years.

\$8 -\$12 K is generated in meter revenues

It is legal to have the parking regulations posted at the entrances to the town.....and this is good to allow for legal ticketing.

The meeting ran longer after an agreement from the committee.

We asked that Captain Sawtelle join us moving forward to participate in this committee.
