LETTER FROM SGT. NEIL REILLY

Gentleman,

I would like to thank you for allowing Officer Smith and I to take part in the meeting last night. I sent an e-mail to the Police Chief and Captain this morning in regard to the information shared last night, currently the Chief of Police is on vacation. I advised that one of the requests was to add a parking tab to our website to make it more user friendly and help alleviate the congestion in the lobby. I compared it to the RMV website and online services.

I advised them about the idea of signage posted in the front lobby to explain how to go online to obtain parking permits. I made an inquiry as to the 36 signs to be posted at each intersection on the east side of Nantasket Ave i.e. "A" Street at Nantasket Ave and "A" Street at Beach Ave etc...and if possible you would like an update concerning our progress on that matter.

I advised that there was a request to have the "total parking tickets by zone" report that the parking committee got last year. I made an inquiry about the implementation of the sign located on Park Avenue "No parking from here to corner". I further explained that there was a request to have the meter poles along Samoset Avenue behind the monument removed since there are no longer any meters there.

I explained that the meeting was very informational and I enjoyed the conversation regarding the handheld devices for parking enforcement. There was a request made that the next time the department has an opportunity for state bidding if possible, that someone from the department do an RFP to purchase these devices and the committee may possibly be able to help pay for them. In my report I included that the committee was very interested in streamlining all parking concerns and was very willing and eager to work with the department moving forward.

I have tried to include all of the information and requests from the committee to the Police Chief and Captain. In the report I submitted this morning I included your e-mail addresses for direct communication purposes. I hope this is helpful gentlemen.
