Notes on the meeting held on 25 August 2016 at 2pm at Village & Smallpox Cemeteries.

The following met at 2pm at Village Cemetery: Dick Boutwell, Bill Driscoll, Bruce Hill, Don MacIsaac, Emily Preston, Rob Stephenson and Charlie Turcotte.

Members reported on their cemeteries: Cutter (Bruce): OK. Phillips-Heil (Bill): granite posts at entrance are leaning. Conant (Dick): no report.

The sleigh hearse in the Hearse House was viewed. There was a discussion about adding windows to the house to make viewing possible. Village Cemetery was toured. It is well maintained with regard to grass cutting. There still remain a number of broken stones. John Kaufhold will be asked if any can be repaired. Bruce will do a sample cleaning of one of the monuments, perhaps at a session during September.

Emily will mention to the owners of the house beside Phillips-Heil about the possibility of evergreens being used to replace the decaying wood-rail fence.

Material provided by Randy Heglin on the gravesite cleaning and maintenance services provided by Cathy Proulx under the name 'Monumental Care" was distributed. The Selectmen have approved her request. Bruce Hill has offered to meet with her to review cleaning materials and techniques.

The Smallpox Cemetery was then inspected. There are several dead trees at the entrance to the path at the Fitch Road cul-de-sac that should be removed. The path itself is in good shape. There is some old dead wood to the sides that could be removed. The cemetery itself has recently been weed whacked. The contract with Katsura should be inspected to see if there is any mention of the Smallpox Cemetery. If not, weed whacking of the cemetery and the path once or twice a year might be added.

The Committee was notified that a NH Old Graveyard Association meeting will be held in Keene at the Historical Society of Cheshire County on Saturday, September 10, starting at 9:30.

There will be no Committee meeting in September but a work session will be held in the Old Burying Ground for stone straightening on a day with good cool weather. Members will be notified by e-mail.
