Impact Fees are now being charged to commercial and industrial as well as residential. The Fee Schedule is calculated from 2013 thru 2018.

Chris Bernier came before the Board to get permission to have the Half Marathon on August 10, 2013. Bernier distributed a map of the course to the Board. He will be meeting with Chief Oswalt as the Chief requests that there be a minimum of five detail officers assigned to work the event, signs regarding the upcoming event need to be posted in advance, the number of "confirmed" volunteers and also adequate signage for parking.

Bernier would like to check into the possibility of having a Farmer's Market on the Well lot. The Board instructed Bernier to discuss this with DPW Director Heglin before he proceeds and also if he would need a permit for a Farmer's Market. Bernier does realize that he needs a parade permit and certificate of insurance and will provide copies to Town Manager Caron. It might be an option to have the Farmer's Market at the Fire Department; Bernier to review with Chief Chamberlain.
