F. Select Board's Business

Selectmen's Reports

<u>Rothermel:</u> Still waiting to hear back from NRRA. Hasn't been to any committee meetings lately. MacIsaac suggested reinstating the recycling Committee, which Rothermel offered to head up the committee. In the past the community had made suggestions as well as NRRA. The aim of the committee would be to streamline the transfer station and recycling having a vision for the station operations, establishing a vision for the Station and how accomplish it. The town should be utilizing NRRA more than it has in the past. MacIsaac suggested the DPW staff should be on the committee, not just citizens.

Moore: Went to see Conant H.S. Principal about a Geographical Tech. class working on a transfer station plan layout. Small class to visit the transfer station and take measurements and make a measured drawing. MacIsaac thought it was a great idea, but DPW needs to be involved in the conception of the idea. Continental Paving has numerous free Jersey Barriers, the Town only needs to pay for transportation. Went to School Board meeting regarding the budget and received a thank you for attending. Also, attended a Budget Committee meeting.

MacIsaac: None

Town Manager's Report

- 2016 Town Budget: Budget Committee has instructed Town Manager to ask departments for operating budgets 95% of 2015 budgets. Need to look at saving about \$ 300,000 on a base of about \$6 million. David will present 2 options to Budget Committee one without cutting services if possible, one with cutting services. Goal is to have budget to BOS 12/14/15 meeting.
- Womans Club meeting on 11/10/15 with updates on new staff, revaluation and town building update; will present at the Chamber breakfast in January with same material.
- DPW was asked to track activities at transfer station.
- Thorndike Pond, Town Manager did talk to DPW and they will be completing some work there before winter.
- Drug Awareness: Hasn't received reaction from other towns involved. When information is received, Town Manager suggested meeting with other towns to get their input. Budget Committee needs to be involved for funding reasons. MacIsaac suggested a warrant article as it would receive more visibility.
