Possible signs to display:

list of prohibited items – carriages, fabric, bedding, tvs etc.

Examine and take items at your own risk

Some swap shop drop-offs require a bulky fee payment, see next door

No ACs or TVs

video surveillance - illegal dumping rules enforced

consider getting rid of tickets

enforce swap shop rules

E-crier article explaining rules

Volunteers should not offer swap shop items to children

new fees new rules

swap shop unloaders Bulky fee

Matt: ordinance for illegal dumping \$100.

Dean: research existing ordinances/laws.

Plan: do one more big load of metal to determine correct disposal of refrigerators, ac, etc.

Randy: Chart of how much it costs and how much we charge

Show ticket when dropping off at swap shop

No longer have to collect tickets

\$2.50 becomes \$5

Matt: we can reduce some prices and still be underneath our costs

SWC recommends the following changes to the bulky fee schedule. Some fees have been eliminated, some reduced, some increased, some unchanged.

No longer charge for: dishwashers, washing machine, stoves, toasters, mixers, small engines (drained)

TVs and monitors, 15 inches diagonal or less \$10

TVs and monitors, 16 inches or more, \$15

Tires, three sizes: \$5, \$5, \$10

Mattresses: \$5 all Overstuffed Chairs: \$5

Sofas: \$10

Fridge & AC & other Freon devices: \$15

Computers and Laptops: \$0

Microwaves \$5 Stereos: \$5

C&D debris: \$5 per 50 lb, \$100 per ton

Propane Tanks: 16lbs: 0; 20lb: \$5; 30: \$10; 100 lbs: \$20

Small engines: \$0

Dean moved we present these fees to BOS Oct 22nd. Matt: 2nd. 4-0 in favor, Toby concurs
