Motion to expose Strafford County Court Judges Wrongs Letter to Judicial Conduct Committee

Judicial Misconduct occurs when a judge acts in ways that are considered unethical or otherwise violate the judges' obligations of impartial conduct.

Now Comes the VRC a (church, religious assembly, a religious faith based on God and Country USA) and so states the harm inflicted by the judicial misconduct of the Strafford County Superior Court (SCSC) to delay ruling in the VRC favor completely when the facts clearly and irrefutable document Constitutional crimes by the Town of Lee NH and the Judges that so presided on this case. The VRC is a "Chapel, church, non-profit, religious assembly) (protected by the Constitution) recognized by the United States of America as a 501-c-3 church, non-profit and the State of New Hampshire as the same. To knowingly allow judges using the power of Strafford County Superior court to discriminate against the VRC and our religious beliefs cannot be tolerated. The TOL and the SCSC have placed a Substantial Burdens, religious beliefs without showing a compelling government interest or that it is the least restrictive means even though the VRC has asked many times. To have judges make rulings in support of the TOL criminal violations of the Constitution in complete disregard for the Law and Constitution cannot be tolerated and constitutes Malice. As follows:

- 1. That the TOL fails to recognize the VRC as a church until we pass their "Site Review committee. The NH superior court in ST. Benedicts center V. Town of Richmond so ruled it is discrimination to do so. This court and the TOL by ignoring the law have placed serious hardship and harm on the VRC and our followers. This act under RLUIPA constitutes a crime with malice.
- 2. That by the TOL with the support and aid of the SCSC did knowingly discriminate by court order to have homeless U.S. Military Veterans, church members evicted from church property to other property in the same town and zone as the VRC to live in less desirable conditions (health and safety conditions) as what appears to be a means of intimidation and demonstration of court and town power to control a mentally and physically disabled person asking for fair and equal treatment under the law. Presbyterian Church V. NY Case NO. 02-0773, RLUIPA. To have the SCSC

judges and the TOL aware that the same homeless veterans were allowed to stay at property about 1 mile away in the TOL and Zoned the same as the VRC property without objection is discrimination and Malice.

- 3. That the TOL did by court order have a portable toilet (rented that all other residents of including the TOL have on their property free and with out any town regulation to stop them) removed from VRC property to inflict harm on our church members by making these members use a 5 gallon bucket lined with a plastic bag and when finished take the content to the Lee Dump. Discrimination by this SCSC and the TOL to single the VRC church members out from all other residents of Lee to make our religious assembly at the chapel a harmful and /or unappealing event to what appears to be to discourage our member from attending our chapel cannot be tolerated. This is a crime under U.S. Constitution and NH constitution with Malice.
- 4. That the TOL with the aid of the SCSC did order the VRC to remove from church property a camper trailer used daily for church missions. All other residents of Lee NH can have trailers on their property constituting discrimination. The same trailer under the suggestion of the TOL moved said camper to property in the same Zone and TOL to be used for church missions, placing harm on our church members. For the SCSC judges to knowing that the same trailer was moved in the same town and zone for church business constitutes discrimination with Malice.
- 5. That the TOL had personal property that told church members where to go removed from church property to inflict harm on our church members. A piece of 4'x4' scrape plywood with the church name printed on it leaning against a flag-pole letters facing away from the road is freedom of speech protected by our constitution but further not regulated by zoning. To have that same scrape plywood when moved to the back of church property by town order 455' from the road sited as a zoning violation and the court to take this as a violation of the SCSC order to remove the plywood constitutes a crime against our constitution with malice. To have the SCSC then take as a violation of the court order that same scrape plywood now framed as a picture with the word chapel removed and a for sale sign attached to it and brought to court constitutes a violation of our constitution by the SCSC with malice. NH and U.S. Constitution Freedom of Speech
- 6. That the SCSC and the TOL were and are aware that the VRC did try over 100 times to get a law firm to represent us but none have the time or money to do so. The TOL and SCSC were clearly informed of my 100% mental and physical disabilities (received defending and protecting the United States of America during times of combat) in what appears to be to use these disabilities to make rulings in complete criminal violations of our laws and Constitutions to stop the VRC cannot be tolerated. ADA

Where Fore: That the facts in this case cannot be disputed and are clear and convincing of the wrongs committed by the TOL and the SCSC we the VRC and our church members the disabled and homeless U.S. Military Combat Veterans so hope

and pray that this Judicial Conduct committee and the NH Supreme Court so recognize that the government including but not limited to the NH Judicial Branch of Government must place the will of the people and never diminish the guaranteed (by our supreme law Constitution) rights of each and every individual at anytime as has been done in this case with Malice. WE are asking for prompt and swift action to stop the wrongs as so clearly stated with unquestionable facts to allow our church to exist and practice with our mission from God to help Homeless U.S. Military Combat Veterans with out further delay. To have the NH Supreme Court or the Judicial conduct committee to allow these wrongs to continue one day longer places harm on our belief in God and Country.

RE: Air Quality Complaint Regarding Outdoor Wood Boiler

Dear Ms. Wheeler

On November 25, 2015, the New Hampshire Department of Environmental Services, Air Resources Division ("DES") received a complaint regarding operation of an outdoor wood-fired hydronic heater ("OWHH") located at 300 Calef Hwy, in Lee, NH (the "Property"). DES believes that you are the owner of the property and the responsible party in this matter.

RSA 125-R, effective August 10, 2008, establishes certain unit setback and stack-height requirements, and permitted fuels for OWHHs, and provides DES with the authority to enforce certain provisions of the law. RSA 125-R:3, *Setback and Stack Height Requirements*, provides that no person shall install a non-Phase I or II OWHH, unless it is located at least 200 feet from the nearest abutting residence and has a permanent attached stack that is at least 2 feet higher than the peak of the roof of a residence or place of business not served by the OWHH if that residence or place of business is located within 300 feet of the OWHH. RSA 125-R:4, *Permitted Fuels*, allow only clean wood and propane to be burned within this type of OWHH.

On December 3, 2015, DES visited the Property and spoke with your employees. During our inspection, DES determined that the stack height was approximately 16-feet above-ground surface. The peak of the roof of A&A Wheeler's main manufacturing building, which is within 300 feet of the Property, appears to be 22 feet from ground level. Therefore, the stack does not meet the minimum stack height as stated in the law. In addition, DES observed small amounts of plywood among the scraps stored in the woodshed adjacent to the OWHH at the Property. Plywood is a treated wood product and therefore cannot be used as a fuel for your OWHH.

As a result, DES has determined that the OWHH does not meet the installation requirements of RSA 125-R:3 and the permitted fuels requirement of RSA 125-R:4. If you continue to use the OWHH, only use fuels permitted under RSA 125-R:4. In addition, the stack height should be corrected so that the OWHH complies with RSA 125-R:3 within 30 days of this letter. This matter will be referred to the Enforcement Section of DES for further review if DES determines that unpermitted fuels continue to be used in the OWHH or if the stack height of the OWHH is not corrected.
