- 1. Chairman John R. LaCourse calls the meeting to order at 6:00 pm.
- 2. Town Administrator Julie Glover presents the power point presentation for the Deliberative Session. The Board reviews and discusses the slides. Ms. Glover explains the warrant articles may be amended by voters at the Deliberative Session (voters may amend but not change the purpose).

 - Selectman DeRocchi advises, articles being amended should follow the 'stay at home' rule. (Meaning if a voter were at home and not attending the meeting, the amendment to the article would not change the intent).

- 6. Town Administrator Julie Glover advises article 4 needs 'raise and appropriate' added to the verbiage.
- 7 The Board assigns individuals to present each warrant article during the upcoming Deliberative Session. Geoff Carlton- Article 3, Joe Lombardo- Article 4, Whichever Petitioner is available Article 5 and Article 6, Andy Lelio- Article 7, Selectman DeRocchi- Article 8, Selectman Griswold- Article 9, Chairman LaCourse- Article 10 and 11, Peter Hoyt- Article 12, Selectman Griswold- Article 13, Tom Dronsfield or Chet Murch- Article 14, Phil Sanborn- Article 15, Roger Rice- Article 16, Allan Dennis- Article 17, Phil Sanborn- Article 18, Peter Hoyt- Article 19, Bruce Larson- Article 20, and Tom Dronsfield or Chet Murch- Article 21.
- 8. Supervisor of the Checklist Clara Corey inquires about the time set up can begin at the Mast Way School. Town Administrator Julie Glover states we can get in at 8:00 am.
