Treasurer's Report of Jan. 2016 accepted: \$9,237.25 in the operating budget; \$2,216.73 in the non-lapsing account and \$6,174.06 in the CD.

Library Director's Report: Ruth thanked the trustees for the plant she received while in hospital; pleased that stats she distributed show increases; announced upcoming library day at ORHS on February 19 where she will distribute magnets; she is meeting with two other area library directors on Thursday, February 18 and shared upcoming programs Loons in NH, Ukrainian Easter Eggs, Essential Oils and others.

- Policy Updates: Bruce moved to accept proposed revisions to ILL policies, approved unanimously. ILL policy: added section to include Borrowing Policy. Rewrote language in Lending policy to reflect current practice (this policy only applies to other libraries). Borrowing policy is for our patrons borrowing from other libraries. Policy on Use of Materials: changes in language to reflect current practice, eliminated mention of video, added unlimited renewals.
