Minutes of last meeting: Accepted.

Finances/ Treasurer's Report: Treasurer's report was accepted. As of Oct. 10, the operating budget was \$3621.28; the balance in the non-lapsing account was \$492.69; and there is \$4,171.04 in the Special Projects Fund.

Library Statistics: In September, circulation was 3444, a decrease of 216 from Sept '09; use of the public access computers was 184, a decrease of 93; wireless usage was 47, a decrease of 19. There were 85 checkouts of downloadable audio books – a decrease of 5 (17 of these were e-books).

## Old Business:

Town Center Steering Committee Update. The next meeting will be October 14 at 7 pm. Chris Hamm, who led the successful fundraising campaign for the Hopkinton Library, will talk to the committee. Katrinka and Cynthia will attend along with Lisa and Peg.

## New Business:

Preliminary Budget Review for 2011-2012. Lisa will submit a place-holder figure of \$6000 for a future automated system for the CIP; the trustees agreed to ask for \$100,000 to be placed in the capital reserve fund – per the CIP plan, to raise the library page's salary to \$10/hour, to follow the guidelines outlined in the Pay Classification Study to raise the library director's salary to an appropriate step, and if the town grants an cost-of-living increase to its employees, to raise the library salaries by an equivalent amount.

Bulletin Board Policy. The trustees agreed to accept postings larger than  $8 \frac{1}{2} \ge 11$ " only if space is available and to accept help-wanted postings for a period of two weeks. Lisa will e-mail these policy changes to the trustees for final approval at the next meeting.

Other. Cynthia, Katrinka and Lisa will meet with Terry Knowles on Thursday, Oct 21 – Cynthia will finalize the time. The trustees approved Lisa's vacation request for the week of February 21.

The meeting adjourned at 6:25 pm. The trustees will hold a budget work meeting on Tuesday, Oct. 26, at 5 pm at Peg's home, to finalize budget amounts before the meeting with the Advisory Budget Committee on Oct. 27. The next regularly scheduled trustee meeting will be Nov. 10 at 4:45 pm at the library.
