LITCHFIELD VISUAL ARTS

Pam Stockamore reported on the upcoming events for Litchfield Visual Arts. The first is the fundraiser the 2011 "Art Grab". It will be held at the Litchfield Historical Society on June 17, 2011 from 6:30-8:30 pm. This will allow a scholarship to be awarded to a college student that is entering their Sophomore or Junior year of college with a major in art or related study. The next priority would be giving a stipend to a local Litchfield artist or artisan to use as needed. That would depend on the amount raised at the fundraiser.

The second event will be the 2nd annual artist exhibition to be held at the Litchfield Historical Society at a time to be determined. The exhibition will be active for approximately three months.

NW CT ECONOMIC DEVELOPMENT CORPORATION

Doug Parker reported that a planning grant is on hold for the NWEDC until the state passes its budget. The commission has been invited to a statewide EDC which should turn into a quarterly meeting.
