Monthly economic updates per region:

- Bantam:
  - Environmental cleanup of Route 209 factory continues.
  - BluePrint CT is moving from Litchfield Green to Carriage House in Bantam; plans to open in May 2018.
  - Haus of Color has a new owner.
  - o New U.S. Postmaster is working on signage and building cleanup.
  - Former Bantam gas station property is in probate.
  - Bantam Annex discussion: A. Haas pointed out that David Dean, commercial realtor and former EDC member, said at the January 2018 EDC meeting that "It's shortsighted for the town to sell the Bantam Annex". As the record of that meeting did not reflect this statement, A. Haas requested it be included in this month's minutes.
  - A. Haas counted 50 brick-and-mortar businesses in Bantam
- East Litchfield: No update
- Litchfield:
  - N. MacMillan-Stedronsky visited Andrew Goldstein and Ideal Jewelers, which moved from Waterbury to the Green. Grand Opening coming soon.
  - Discussion on how to fill vacant shops in town.
  - A coffee shop is coming to Cobble Court.
