#### <u>UPDATE ON YALE NEW HAVEN CANCER CENTER</u>

EDC members will continue to monitor developments between Charlotte Hungerford Hospital and Yale New Haven Hospital to partner and provide cancer treatment services in Litchfield County. The cancer center currently located on Kennedy Drive in Torrington will have to relocate because federal regulations require that a satellite facility must be within 35 miles of Yale-New Haven's home base in New Haven. The 35-mile range, interpreted as the "crow flies," would put the new facility somewhere in the south end of Torrington, Litchfield or points south.
