  - Implementation of plan is as important as drafting the plan itself. Part 2 of plan is the "Toolbox" – samples, models and case studies related to each of the plan's strategies. COG will build the toolbox over time, soliciting input as tools in the toolbox are being used. Quarterly review of POCAD and toolbox.
  - Working now on the ED 5-year plan with NWEDC and NW Chamber of Commerce; expected completion date is April 2018.

  - J. Ayers will email us white paper on Air BnBs to be discussed at January 2018 Litchfield EDC meeting.
  - O Would Litchfield EDC be interested in having COG assist with business visitations?
- Lee Losee: Litchfield Borough Warden
  - Discussed and solicited ideas regarding the unstaffed Information Booth on the Green including:
    - Volunteers including high schools students to help with electronic options
    - Self-service options
    - Interactive kiosk
    - Blended solution that includes print and electronic options (requires wireless on the Green)
