- a. <u>December YTD Budget to Actual Report</u>: Discussion ensued regarding December Budget to Actual. Noted variances discussed at length.
- b. <u>Detail of Employee Benefits: Program 61</u>: Handout given and variances noted. Specifically noted that early retirement for the current year to be paid in the near future to the Town of Litchfield. Town Pension has not been invoiced yet, but will be paid when received. Health Insurance appears to be on track.
- c. <u>Detail of Special Education Tuition: Program 93</u>: Discussed Special Education being over budget. Anticipate Special Education tuition to exceed budget. Variance does not include Excess Cost Grant estimated at \$200,000.
- d. Excess Cost Grant Projection: Estimated \$200,000 and discussed in item c.
- e. <u>2.5% Municipal Budget Cap</u>: Discussed the information supplied by CASBO lobbyist.
- f. <u>Energy Bid Electricity Generation</u>: Currently in a 3 year contract. Did a competitive bid through an energy broker. Currently locked in until December, 2018 at 7.9 cents per kWh. Extended term to December, 2019 at 7.35 center per kWh. Had 4 bids.
- g. <u>Fuel Oil Bid 207-2018 School Year</u>: Part of a consortium with Town of Woodbury, Regional School District #6, Oliver Wolcott Library, Litchfield Housing Authority and Connecticut Junior Republic. Bid opening will be Friday, January 13, 2017.
