Litchfield FD air conditioning project was discussed. The Commission asked E. Evers to change the capital request for this project from \$155,000 to \$175,000 because the lower figure is based on an estimate that is a year old. J. Hodges moved to approve proposed 2018/19 capital requests as follows: East Litchfield energy and code updates to vestibule, windows and doors in the amount of \$70,000, Litchfield Fire roof/air conditioning unit in the amount of \$175,000 and the hall ceiling for \$22,000, Bantam Fire for parking lot repairs \$250,000 for a total of \$517,000, G. Shuhi seconded and motion passed unanimously. A discussion ensued regarding this year's remaining capital projects.
