Installation of new septic tank, pump chamber and pressure line. Installation of new well and removal of existing pump house.

Fritz Rohn was present with drawings and explained the plan to install a new septic system and a well. The current septic system is old but is working adequately. The new system is needed because Torrington Area Health District requires an updated septic system if a well is to go in. A pump chamber and storage tank will go in the area of the current system and will pump uphill about 400 ft. to the new system. Dr. Schildgen was comfortable with Ken Hrica as the engineer and felt there was no need to have Mr. Rohn come back next month. A. Paradise noted the radius from the well extended beyond his property. R. Blazek added they do not regulate subterranean ground water.
