Replace damaged wall around parking area with new stone wall

Ted Murtha showed a photo of an old rail tie wall he wants to take out and replace with a 20-ft. stone wall. The water is 25 ft. from the wall. He will also remove rocks and stumps.

Replace/construct septic system in upland review area

Steve Latour, Berkshire Engineering and Surveying, showed his map of 241 Brush Hill Road. John Graham is seeking a permit because the septic has failed and is backing up into the house. He wants to expand the house to three bedrooms and will put in a new system in the regulated area. It's a gravity system, and Mr.

Latour presented a copy of the permit from Torrington Area Health District. Mr. Blazek noted this as a safety issue.

3. PurePoint Energy, LLC for Plumb – 267 Beach Street

Installation of 120-panel ground mount solar array

Frederick Plumb, 267 Beach Street, said he would like to cover 100% of the power needs on the farm with this solar array that PurePoint Energy will install. It is close to an intermittent brook in the regulated area. The panels are 16 ft. from the stream. He would like to prepare the site by filling the area to level it. He will use silt fence and hay bales. He will put fabric down, and then stone under the panels so there is no maintenance once the panels are installed. PurePoint will augur the poles for the panels in. Upon request by Mr. Blazek, he will have Dennis McMorrow take a look at it for design and bring a plan to the next meeting. He will also have Dennis Tobin take a look at the trenching for the electrical conduits.

Approval for parking on Phase 2 & Phase 3 foundation slabs and on existing asphalt surface at north end

Jack Nelson showed his maps, one for parking layout and one for the demolition phasing plan. They will be demolishing Phase III within the next month and would like permission to park on Phase II at existing slab level. Silt fence and hay bales will be used for the demo.

Permit Modification: Revise description of authorized activity

There had been no communication with the State about river encroachment, so they would like to be able to stabilize the river embankment so they can continue working. Riprap will go on the river bank behind the building. R. Blazek said he can re-issue the permit deleting "notify the State for encroachment." They will add this language to the permit.
