**Minutes of May 21, 2012**

- 1. Chairman, Susan Lowenthal, called the meeting to order at 7:00 p.m.**

    - ii. Motion by Bramley, second by Post, to approve the application, affirmative vote unanimous.
    - iii. Lowenthal noted that the approval must not be construed as a variance for the location of the sign(s).

- i. Jerry and Janice LaPlaca, owners, were present. Peter Herbst, their attorney, was present with green cards. Ken Hrica, engineer, was also present with an engineering report and presentation. Michael Morressy, propane consultant and State Director of the National Propane Gas Association, was present with a PowerPoint presentation. Arthur Oles, certified appraiser, was also present with a presentation on the project's likely impact on neighborhood property values. Also present was Jack Robinson, of East Coast Utility, the contractor who would build the facility. Vince Dermott, planning consultant, of Milone & MacBroom was present, representing the Commission, to review the technical aspects of the LaPlaca team's presentation.

Margaret Minor, of Rivers Alliance of Litchfield, was present with a petition with 32 signatures against the application on environmental grounds, of which circa 80% (Lowenthal's estimate), represented Litchfield residents. Ms. Minor also presented a letter from the Housatonic Valley Association requesting denial of the application. Minor presented copies of her testimony to the Inland Wetlands Commission as well as her testimony today.
- x. The hour being late, Lowenthal recessed the Public Hearing until June 18<sup>th</sup>. Correspondence received but not yet read will be read into the minutes on June 18<sup>th</sup>.




