In this file and during this Public Hearing the terms “Fire Safety Report” and “Fire Safety Analysis” are employed interchangeably. Lavengood also introduces an undated diagram titled “Pneumatic Valve System” and submitted it for the file.
- l. Alicia Pecora, neighbor and owner of the Toll Gate Inn, was present to speak against the application and submitted a letter dated June 18, 2012
- m. Sean Hutton, of the Rivers Alliance of Connecticut, was present to oppose the application and presented a letter dated June 18, 2012.
- n. John Keilty, living on Wheeler Road in East Litchfield, was present to speak in favor of the application.
- o. Betsy Glassman, Litchfield resident, was present to speak against the application.
- p. Byron Rondos, owner of DaCapos restaurant, was present to speak against the application and submitted an email from Denada Markaj dated 6-18-12.
- q. Joseph Oskwarek, part owner of nearby Tail Waggers, was present to speak against the application.
- r. Damien Oskwarek, neighbor, and part owner of Tail Waggers, was present to speak against the application, and submitted a petition in opposition titled “Petition to Town of Litchfield and the Inland Wetlands Commission,” said to contain 130 signatures of neighbors opposed to the application.
- s. Joseph Manes, neighbor, was present to speak against the application. Submitted two separate newspaper articles for the file said to report on recent traffic accidents in the neighborhood of the subject property.
- t. David Redente, owner of Peaches and Cream, was present with questions and comments.
- u. Marcia Fowler, neighbor, was present to speak against the application
- v. Jim Hollanden, neighbor, was present to speak against the application
- w. Brian Dingwell, Litchfield resident, was present to speak in favor of the application
- x. Noel Fisher, resident of Milton, was present to speak in favor of the application, with qualifications.
- y. Responses to issues raised in the public comments were offered by technical experts Morressy, McDermott, Lavengood, and Hrica. Commissioners further questioned these technical experts. Damien Oskwarek joined the discussion. Betsy Glassman joined the discussion.
- z. At 11:26 the Public Hearing was continued to July 16, 2012. Motion by Waterhouse, seconded by Post, affirmative vote unanimous. NB, This motion and vote also adjourned the Commission. See “Adjournment,” 12 a, below.


