2. Introduction to Planning Consultant Sean Suder, managing Director, Graydonlanduse Members of the commission were introduced to Sean Suder via conference call.

Commissioners reviewed the packet of material with a preliminary draft proposal for the format of the regulations dated December 31, 2014. The proposed format and content presented was discussed with the consultant. Items I. through VII. were reviewed and it was determined there were areas that could be deleted as well as some that could be added. It was agreed VI. A. should include information on enforcement and that a section E. be added to include ZBA and variances. The sample page entitled "Residence Districts" was well received as a much simplified and clear way to describe the standards and uses associated with each of the zoned districts in town. The Commission liked the idea of the "Glossary of Defined Terms" being located at the end of the regulations and suggested the "Table of Uses" be placed at the end as well as an Appendix. The sense of the commission was that the work by Graydonlanduse to date has been positive and productive. The consultants will be present for the Commission's workshop meeting on February 2, and will provide a first draft of the regulations for discussion and review.
