Law Enforcement Report: Greg Kenney presented a report detailing DWI and Narcotics arrests data from 2016 and 2017. Of interest to Officer Kenney is that the data shows a trend toward higher Blood Alcohol levels in 2017, and more arrests occurring in early evening hours than late evening/midnight.

Project Purple- discussed ribbon distribution for 2018. One or two members will accompany student group; all other members will distribute ribbons in target areas on their own time. Bring flyer with mission statements.
